What's new in *The Cochrane Library*?

New Reviews

- ✓ Clinically- indicated replacement versus routine replacement of peripheral venous catheters.
- ✓ Fibrinolytic agents for acute arterial occlusion.
- ✓ Direct thrombin inhibitors versus vitamin K antagonists or low molecular weight heparin for prevention of venous thromboembolism following total hip or knee replacement or hip repair.

Protocols

- ✓ Local transplantation of autologous mononuclear cells for critical limb ischaemia.
- ✓ Angioplasty versus stenting for stenosis of the subclavian arteries.
- ✓ Heparin versus 0.9% sodium chloride intermittent flushing to prevent occlusion in central venous catheters in adults.
- ✓ Stent graft type for endovascular repair of abdominal aortic aneursysm.
- ✓ Stent graft type for endovascular repair of thoracic aortic aneurysm.
- Remote ischaemic preconditioning versus no remote preconditioning for vascular and endovascular surgical procedures.
- ✓ Primary prophylaxis for venous thromboembolism in ambulatory cancer patients receiving chemotherapy.

- ❖ The 2009 impact factors (IF) have now been published by Thomson ISI. The Cochrane Database of Systematic Reviews has an IMPACT FACTOR of 5.653 and is ranked 11th out of 132 in the ISI category Medicine, General & Internal. - ❖ The Lancet have announced that they will ask authors of all research reports submitted after August 1 2010 to put their work into the context of what has gone before, by either reporting their own, up-to-date systematic review or citing a recent systematic review done by others. This is important recognition of systematic reviews as a key element in understanding the findings from all new research.
